NOTES

- Child rates are valid for children between 2 – 11 years of age & if sharing a family room with minimum 2 adults.
- Children under 6 years of age not allowed on game drives at game lodges or on the underground mine tour at Gold Reef City
- South Africa does not have a "no bed" policy for children. Children will be accommodated on a standard
- Certain accommodation establishments refuse permission to children under 12 years of age, e.g. certain private game lodges. Supplier child conditions will apply in these cases.
- Certain accommodation establishments only accept children in family units. These units are often in limited supply and subject to availability. Acceptance of any child on discounted conditions is therefore subject to availability and confirmation of such units.
- Children may not be allowed to go on game drives. Some of the lodges do offer babysitting facilities at an additional charge. Guests need to arrange the babysitting services upon arrival at the lodge and need to settle the service directly.
- New regulations for families travelling with children to and from South Africa
- The South African immigration department has expressed concern about the growing issue of global child trafficking and has announced new requirements for adults travelling with children under the age of 18, which will take effect from 1 June 2015. Parents travelling with children would now be requested to provide an unabridged birth certificate (including the details of the child's father as well as the mother) of all travelling children. This applies even when both parents are travelling with their children. When children are travelling with guardians, these adults are required to produce affidavits from parents proving permission for the children to travel. The above applies to foreigners and South Africans travelling to or from South Africa as well as travelers in transit.
- Regulations for families travelling with children to and from Botswana
- Botswana immigration requires that all children under the age of 18 entering and exiting the country need to produce an unabridged birth certificate. This can be either the original or a certified copy.
- Full day vehicle is 8-9 hrs. And half – day is 4-5 hrs. On the garden route, the vehicle is available for 10-12 hrs. Any extra hours required may not be allowed and is purely on request and will be charged for.
- The drivers/guides may not stay in the same hotel as the clients. It is customary to pay 10% gratuity (tips) both to the driver and the guide to ensure more pleasurable services.
